The information gathered is multi-purposed.

A. Knowing age and names of children approaching their 26th birthday allows for the club to accommodate for new member requests as part of our long-range planning. The Constitution (Dated 1/21/2017) allows children to remain on their parent's membership until their 26th birthday unless they marry first.

B. Annual Dues adjustments: (Constitution dated 1/21/2017) Having the above data on file allows the club to confirm dates of birth and remind members when they become eligible for adjusting their dues in advance. Please note your voting power is altered by requesting an adjustment in your dues, see HSC Constitution.

1. Members at 70 years of age with 30 years or more of continuous membership may request their annual dues be "frozen" to the amount being billed in the year of the corresponding birthday. Other than 2019 when dues were prorated.
2. Members at 75 years of age with 30 or more years of continuous membership may request their dues be cut in half.
3. Members at 80 years of age with 40 or more years of continuous membership may request their dues be waived.

All requests for dues adjustments, listed above, must be made by notifying the Board, preferably in writing. A form is on the website that can be returned to the HSC Treasurer for Board approval. The **Website is: hanoverseaside.com**. Click on Quick Links, then scroll until you see "Application to request change in membership status."

C. Requesting information on names of married children allows the Room Reservation Committee to better fulfill the requests for multiple rooms when the Committee is assigning the summer third floor rentals prior to the season opening each year.

D. This form will be placed on file at the club, compiled and distributed for internal use only.

E. It is the responsibility of each member to update their personal information with the Club. A request for such data will most likely be requested every five years to maintain all data is current.
